3. SCOPE OF WORK

- 1. Professional representation is required on behalf of corporation with respect to cases pending for previous A.Ys, assessment proceedings / appeal under direct tax law , draft replies to notices / demand received, if any, etc.
- 2. Follow up of amount refundable under VSV scheme, (Form- V has been issued by the Department).
- 3. Assistance in Preparation and vetting of estimates for payment of quarterly installments of Advance Income Tax / Self-Assessment Tax in purview of adoption of the non-going concern basis of accounting.
- 4. Preparation, vetting and filing of Income Tax Return for the A.Y. 2021-22.
- 5. Reconciliation of TDS as per Books of Accounts with the Form 26AS available on Income tax web-site and reconciliation of Income as per Form 26AS and Books of Accounts.
- 6. Filing quarterly TDS returns / revised returns through Compu Tax software after verifying from ledger in stipulated time.
- 7. Assisting in preparation of details required for completion of tax audit.
- 8. Attending to all communications, Notices of Tax authorities and appearance at hearings before tax authorities in respect of all present and past appeals/ proceedings/ matters.

3. Preparing and submission of bid:

STC will issue the letter of Award (LOA) to the successful bidder and communicate the same through written communication through email as per details given by bidder. The said communication on acceptance will constitute the formation of a Contract.

6. Termination of Appointment

A. By STC

STC reserves the right to terminate the appointment on occurrence of any of the following events.

- a) Any document, information, data or statement submitted by the Firm in its proposal, based on which the bidder was considered eligible or successful, is found to be false, incorrect or misleading.
- b) The Firm fails to commence services as required under this agreement.
