**SUB: Letter of Award as “OUT-SOURCING AGENCY” for Fertilizer  
Distribution to Tobacco Growers in the State of Karnataka – Reg.**

With reference to your participation in tender no STC/BNG/FER/2018-19/03 dt 17.04.2018 invited by STC for awarding the work of Distribution of Fertilizers to Tobacco Growers in the state of Karnataka on behalf of Karnataka Varginia Tambaku Belegarara Sangha (KVTBS), M/s. Lalitha Bio Tech, is hereby awarded the job of “Outsourcing Agency” for the crop year 2018-19 by STC.

**The Scope of the operations have already been listed both in our Expression of Interest dtd. 17.01.2017 and in the Tender Documents dtd. 17.04.2018.**

1. You shall be appointed as “OUTSOURCING AGENCY” for the year 2018-19.
2. You shall be paid rate at the rate of Rs. 511/- Per Metric Ton for carrying out the entire operations including man-power requirement for laborers, supervisors, security, computer operators and other allied work required for the operation as specified in the Tender.
3. Above rate of Rs. 511 /- per MT payable to you is all inclusive including Goods and Service taxes and other taxes payable for the operation. GST claimed by the Agency shall be paid/reimbursed only once the credit of the same is reflected in the GST portal.
4. STC officials posted in platforms for above operations shall only be doing overall supervision and for the purpose of interaction with Tobacco Board superintendents and officials of Agriculture Department. All the receipt of stocks, dispatch to farmers, stacking of cargo, accounting, reporting, reconciliation of stocks etc are to be carried out only by persons posted by you at various platforms.
5. All shortages & pilferages in above operation shall be your account, cost of which is payable by you, which will be adjusted from the amount payable to you.
6. STC shall not accept any claim whatsoever in nature for carrying out the distribution operations over and above the amount of Rs. 511 /-per MT agreed for above operations.
7. All our terms and conditions remain unchanged and applicable, as per the Expression of Interest No. STC/FER/EMP/2016-17/01 dt. 17.01.2017 and our Tender No. STC/BNG/FER/2018-19/03 dt. 17.04.2018.
